

#### Supreme Court Cases and Orders

#### High Court Cases

Westlaw India contains over 540,000 full-text decisions from 26 High Courts. Coverage starts from 1886 and case headnotes are included for a large number of editorially selected judgments. Like the Supreme Court, every High Court judgment is supplemented with our unique Case Analysis documents, enabling users to view a judgment's appellate history through seamless linking between High Court and Supreme Court decisions.

#### Intuitive Searching

Depending on whether you are looking for something general or something very specific, you can tailor the type of search that you carry out.

Using our Advanced Search option, you can narrow a search down to a case name or the provision number of an act.

#### Citator



The Citator feature brings forth the qualitative aspects of cases and statutes. A citator indicates whether or not the law in a particular case has been followed, modified, or overruled in subsequent cases

You will come across the following symbols while researching in UK, U.S. & Canada cases that indicate the status of the cases. This feature is now also available in Indian content, starting from all Supreme Court cases.

The C in green indicates the case has received positive or neutral judicial treatment and is a good law of reference.

The yellow exclamation mark indicates that the case has been judicially considered and has received mixed or mildly negative treatments, such as distinguished, criticized, etc.

The Red "No-entry' indicates that at least one point of law has been overruled or reversed. This is an immediate notification that the case is no longer good law.


Alerts are the ideal way for you to stay informed on just about everything happening in the legal market. And because you're in control of the content, there won't be any spam.
